



2019 Albany Auto Show “Crushed Car Contest” Contest Official Rules

No Purchase Necessary

Contest Begins Friday, November 1, 2019 at 3:00 pm and ends Sunday, November 3, 2019, at 5:00 pm.

1. All entrants of the 2019 Albany Auto Show “Crushed Car Contest” Contest must be at least 18 years of age, have a valid driver’s license, and be a legal resident of the 50 United States or the District of Columbia. Employees of ENYCAR, its members, its members’ employees, and their immediate families are not eligible to participate. Employees of the Times Union Center, SMG and their immediate families are not eligible to participate. Employees of Ben Weitsman, Upstate Shredding, and their assigns and immediate families are not eligible to participate. Albany Auto Show exhibitors, their employees, and employees’ immediate families are not eligible to participate.
2. Contest sponsored by ENYCAR (“Sponsor”), The Times Union, and Ben Weitsman/Upstate Shredding.
3. Entries must be received between Friday, November 1st at 3:00 pm, 2019, and 5:00 PM on Sunday, November 3rd, 2019. All entries must be on official entry forms, no photocopies or hand-drawn entry forms will be accepted. Entrants may enter by completing entries at the show information booth on the upper level at the Albany Auto Show located at the Times Union Center or outside the box offices. Limit one (1) entry per person per day. The sponsors are not responsible for lost entries, technical failures, or unauthorized human intervention. All entries submitted become the property of ENYCAR and cannot be returned.
4. Entries which Sponsor determines, at its discretion, to be incomplete, incorrect, illegible, or not in accordance with these rules, will be disqualified without notice to the entrant. Official rules are available at www.albanyautoshow.com/prizes-and-events/.
5. If, in Sponsor’s opinion, there is any suspected or actual evidence of fraud, electronic or non-electronic tampering or unauthorized intervention with any portion of this Contest, or if fraud or technical difficulties of any sort (e.g., computer viruses, bugs) compromise the integrity of the Contest, Sponsor reserves the right to void the suspect entry and/or terminate the Contest and award the Prize in its sole discretion. The use of any automated launching or entry software or any other mechanical or electronic means that permits the participant to automatically enter repeatedly is prohibited.
6. Odds of winning depend upon the number of entries received.
7. Need not be present to win.
8. The winner will be determined by the entry that most correctly identifies the motor vehicle. Entrants will answer three (3) questions to identify the motor vehicle: Vehicle Make, Model, and Year. Entrants will also be asked to identify the vehicle’s Mileage at time of compaction (as a tie breaker). Entries with all of the first three incorrect answers will be eliminated from the Contest, unless all entries are entirely incorrect, in which case a random drawing of entries will be held. In the event that multiple entries

correctly answer the vehicle make, model, and year, or the best entries correctly identify only two of the three fields, or the best entries correctly identify only one of the three fields, the tie breaker will be determined by the entry that comes closest to correctly stating the Mileage as was indicated on the odometer at the time of compaction. If after the tie breaker, there remains a tie in correctly stating the Mileage as was indicated on the odometer at the time of compaction, a random contest from these entries will determine the winner. The winner will be determined on Monday, November 4th, 2019.

9. One (1), prize of \$500.00 will be awarded.

10. A representative of ENYCAR will notify the winner. While reasonable attempts to notify winner will be made, it is the responsibility of the winner to be available for notification. In the case where winner cannot be reached within five business days or is unable to claim the prize within ten business days of notification, one replacement winner will be chosen, under the same terms and conditions, and if those are not met, no further replacement winner will be chosen. The Sponsor is not responsible for and shall not be liable for late, misdirected or unsuccessful efforts to notify a potential winner. If the winner chosen does not claim the prize within the appropriate time given upon notification or unless otherwise stated herein, the entrant winner will automatically be disqualified and their prize will be forfeited, no alternative prize will be substituted. Furthermore eligible entrants agree as follows: By participating, you agree (a) to be bound by these Official Rules; (b) as between you and the Sponsor, that the decisions of the Sponsor is final on all matters relating to the Contest; (c) you are not participating on behalf of any employer or third party; (d) in the event that you not comply with the rules, then the eligible winner will be disqualified.

11. All decisions of the Contest judges are final. In the event viruses, bugs, unauthorized human intervention, Acts of God, acts or regulations of any governmental authority, war, national emergency, accident, fire, riot, strikes, lock-outs, industrial disputes, acts of terrorism or other matters beyond the Sponsor's reasonable control, corrupt, prevent or impair the administration, security, fairness or proper play of the Contest, so that it cannot be conducted as originally planned, except where prohibited by law, Sponsor has the right, in its sole discretion, to modify the Official Rules or to cancel, modify, terminate or suspend the Contest; and in such event, to select a winner by such method as Sponsor in its sole discretion shall consider equitable.

12. Except where prohibited, the potential winner will be required to pick up the prize in person and to sign an Affidavit of Eligibility, Liability & Publicity Release ("Affidavit"), in order to claim the prize. If a potential winner cannot be contacted, fails to execute and sign the Affidavit, does not comply with these Official Rules, or does not take delivery in person of the prize in a reasonable time period, potential winner forfeits the prize.

13. By submitting an entry form, entrants agree to be bound by the rules of the Albany Auto Show "Crushed Car Contest" Contest, and agree that sponsors shall have the right, free of charge, to publish and/or broadcast by any means the name, city of residence, photographs, and statements of the winner and finalists.

14. By participating, entrant agrees to release and hold harmless Sponsors, affiliates, subsidiaries, and the directors, officers, agents and employees of any of the organizations, from all claims or damages, in equity or in law, arising out of participation in the Contest as well as any and all liability arising from the acceptance and/or use/misuse of the prize. The winner must present a valid drivers' license in person and sign an Affidavit of Eligibility and Release to claim the prize. Should the winner be deemed ineligible

according to the official rules, he/she will be automatically disqualified and will receive no compensation. No transfer or assignment of prize is allowed, except at the sole discretion of the Sponsor.
